### 2. Possible Dangers

### 3. Composition

Aqua, Caprylic/Capric Triglyceride, Glycerin, Urea, Panthenol, Cetyl Alcohol, Glyceryl Stearate Citrate, Methylpropanediol, Dicaprylyl Ether, Saccharide Isomerate, Olea Europaea Fruit Oil, Tocopheryl Acetate, Butyrospermum Parkii Butter, Squalane, Ceramide NP, Caprylic/Capric/Myristic/Stearic Triglyceride, Hydrogenated Coco-Glycerides, Cellulose, Dodecane, Dehydroxanthan Gum, Caprylyl Glycol, Hydrogenated Lecithin, Pentylene Glycol, Phenylpropanol, Sodium Phytate, Alcohol, Citric Acid, Sodium Citrate.

### 4. First aid measures

Measures for

- Accidental contact with eyes: immediately rinse thoroughly with plenty of lukewarm water; consult an ophthalmologist as a precaution if irritation persists.
- accidental ingestion of large quantities: do not induce vomiting. Rinse out oral cavity and drink about a glass of water. If necessary, consult a poison control centre or doctor. In case of babies/toddlers always consult doctor or poison control centre as a precaution.

When consulting a doctor or poison control centre, always have the packaging or label ready.

### 5. Fire fighting measures

All common extinguishing agents are suitable.

### 6. Accidental release measures; disposal

In case of spillage/leakage: Absorb main quantity with cloth; remove remainder with water and common cleaning agents.

Packaging should be returned to the collection of recyclable materials empty of residues. Filled, unused packages must be disposed of separately according to the waste guidelines of the municipality.
