## SECTION 4 - FIRST AID MEASURES

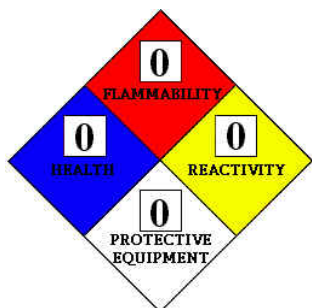
